OLD Bussiness.

Bill Garwood said that he had received a set of Guide lines from the County as to Covenants on the Subdivision and they might have to have a Legal opinion on the Enforcement of the Covenants. Dave said he had received a bill from Larry Stetter on the work on the Lower Road. It came to \$1,257.85 and that Larry Stetter had give the Subdivision Credit on \$257.85 to put this at \$1,000.00. Which was approved for this work. Bruce reported that he had been in contact with the County on our taxes most all Lots would go up 25%. Last years taxes were \$598.00 and this years would be approximately \$929.00. Bruce said he had talked to Mike McDonald (who is a Assessor) and he would go to Lander to see if he could get this reduced. Bruce said he would follow up on this.

Road Repairs on Spruce Creek Ct. Bruce and Dave agreed that we should put some 3 to 4" rock in the ditch that is washing so bad. and that the Culvert should be replaced with a larger one as there is only a small PVC pipe in now. Bruce said that he would get a price from the Local Contractors on their items along with a price on moving Green River Court Rd.

Patty said that Dinah Wilhite talked to her abour putting gravel on the Road from their lot line to the hill by Jack Barnwells. Patty made a motion to have Bruce get a estimate from Bill Leseberg and Larry Stetter for this work. Dave seconded. Motion carried.

Bruce said that before Winter. We should put some fill in the road past Mark Gale's to help eliminate the snow problem. We should also put some fill in the draw by Kurt Koegler where the Water froze up last winter and see what could be done by Bob Hitchock to eliminate the main line freeze up.

B.T. Killion talked about the water hook up to Ciocarlan's and that Ciocarlas's was a Legal hook up but that Harold Cheek had taped into Ciocarlan's line making Cheeks a illegal hook up.

Bruce said that Kay Connelly would get her fence moved by the Upper Water Tank as soon as she could get some one to do it.
