  - (g) Motion that on August 1, 2022, the Secretary shall verify the eligibility of candidates, pursuant to the ULWSA Bylaws. Then, the Secretary shall forward the complete list of verified candidates to the President. The President shall then announce to the Members via eMail and posting to the ULWSA web site. Candidates who declare by August 1 shall be included on such proxy forms and ballots as are produced by the ULWSA. Candidates who fail to announce their intention by August 1, 2022 shall be eligible for election only via write-in on a ballot. (sponsored by Eriks Goodwin)

In the event of disagreement between President and Secretary, the question shall be brought before a Special Meeting of the Board of Directors with a simple majority to determine the outcome. - (k) Motion to authorize sending of a second owner notification mailing for the 2022 Annual Meeting on August 2, 2022. Contents to be agreed upon by the President and the Secretary (appealable to the full Board if not in agreement) prior to mailing. The mailing shall include:
  - i. Notice of Annual Meeting (include location, time and place)
  - ii. Notice of Availability of proxies and instructions on how to request them
  - iii. Candidate Fliers (no more than one letter size sheet of paper per candidate, can be single or double sided)
    - A. To be included in the mailing paid for by the ULWSA, candidate fliers may not contain personal attacks or personal criticism of any kind. It would be inappropriate to allow owners to attack each other using ULWSA funds.
    - B. For electioneering other than ULWSA mailings, candidates may do as they wish, within the law, at their own expense.
